

JALISCO CHICAGO GIVEAWAY 2026

OFFICIAL RULES & TERMS AND CONDITIONS

Entry Period	September 10-16, 2026
Activation Locations	Navy Pier and Grant Park / Millennium Park, Chicago, Illinois
Administrator	Envoy Events, acting on behalf of the tourism promotion entities of Jalisco, Guadalajara and Puerto Vallarta
Winner Selection	On or before September 20, 2026

1. NO PURCHASE NECESSARY

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE THE ODDS OF WINNING. By submitting an entry, each participant agrees to be bound by these Official Rules and by the decisions of the Administrator, which will be final with respect to the administration and selection process, subject to applicable law.

2. PROMOTION PERIOD AND LOCATIONS

The Jalisco Chicago Giveaway 2026 (the "Giveaway") will accept entries beginning September 10, 2026 and ending September 16, 2026. Entries will be collected in connection with the Jalisco consumer activation in Chicago, including activities at Navy Pier and Grant Park / Millennium Park. Entries received outside the stated entry period may be deemed ineligible.

3. ELIGIBILITY

The Giveaway is open to legal residents of the United States who are 18 years of age or older at the time of entry. Employees, officers, contractors and immediate family members of Envoy Events, the participating tourism entities, participating hotels, airline partners, and any organization directly involved in the administration or fulfillment of the Giveaway are not eligible to win. Void where prohibited or restricted by law.

4. HOW TO ENTER

To enter, participants must complete and submit the official Giveaway entry form during the Entry Period. The form may request information including first name, last name, email address, telephone number, city and state. Limit one entry per person unless otherwise expressly stated at the activation. Incomplete, duplicate, automated, fraudulent or otherwise non-compliant entries may be disqualified.

5. PRIZES

The Giveaway is expected to award one (1) Grand Prize and five (5) additional prizes. The Grand Prize is a Jalisco trip for two (2), expected to include round-trip airfare and a total of seven (7) nights combining Guadalajara and Puerto Vallarta, with the Puerto Vallarta portion including a three-night stay for two adults at Barceló Puerto Vallarta in a Deluxe Suite with an all-inclusive package. The Guadalajara hotel certificate and final Grand Prize travel details are subject to confirmation before fulfillment.

The five (5) additional prizes are individual hotel certificates for Puerto Vallarta, currently consisting of stays provided by Fiesta Americana Puerto Vallarta All Inclusive & Spa, Blue Chairs Beachfront Resort, Meliá Puerto Vallarta, Costa Sur Resort, and Krystal Puerto Vallarta. Each additional winner will receive one (1) certificate only. Specific room categories, occupancy limits, meal plans, validity periods, blackout dates, reservation requirements, service charges and other restrictions are governed by the applicable hotel certificate.

6. PRIZE CONDITIONS

All prizes are subject to availability and to the terms, conditions, blackout dates and expiration dates established by the applicable airline, hotel or prize provider. Unless expressly included in the applicable prize certificate, ground transportation, baggage fees, taxes, gratuities, resort or service fees, meals, tours, personal expenses, travel insurance, passports or other travel documentation, and incidental expenses are the responsibility of the winner. Prizes have no cash alternative, are not redeemable for cash, and may not be transferred except where expressly permitted by the prize provider. No extension or substitution is guaranteed.

7. WINNER SELECTION

Envoy Events will be responsible for administering the winner selection process on behalf of the tourism promotion entities of Jalisco, Guadalajara and Puerto Vallarta. Potential winners will be selected from eligible entries on or before September 20, 2026 through a random selection process administered by Envoy Events. Odds of winning depend on the total number of eligible entries received.

8. WINNER NOTIFICATION AND CLAIM

Potential winners will be contacted using the email address and/or telephone number provided on the entry form. A potential winner may be required to confirm eligibility, provide identification, sign an eligibility/release document, and provide any information reasonably required to issue or redeem the applicable prize. If a potential winner cannot be contacted, fails to respond within the period stated in the notification, is determined to be ineligible, or declines the prize, the prize may be forfeited and an alternate potential winner may be selected.

9. TRAVEL RESPONSIBILITY

Each winner and any travel companion are solely responsible for satisfying all travel requirements, including valid identification and any documents required for air or hotel travel. Travel companions may be required to travel on the same itinerary as the winner. Changes, cancellations or missed travel after confirmation may result in forfeiture and are subject to the policies of the applicable travel provider.

10. DATA COLLECTION AND PRIVACY

Information submitted through the Giveaway form will be used to administer the Giveaway, validate entries, contact potential winners and fulfill prizes. Where a participant separately opts in to marketing communications, the participant's information may also be used to provide tourism news, travel inspiration, promotions or communications from participating destination organizations and partners in accordance with their applicable privacy practices. Marketing consent is not required to enter or win. Participants should not submit information on behalf of another person without authorization.

11. PUBLICITY

Except where prohibited by law, acceptance of a prize constitutes permission for the Administrator and participating tourism entities to use the winner's first name, city/state, likeness and prize information for reasonable Giveaway-related announcement and promotional purposes without additional compensation, subject to any consent required by applicable law.

12. RELEASE AND LIMITATION OF LIABILITY

To the fullest extent permitted by law, participants and winners agree that Envoy Events, the tourism promotion entities of Jalisco, Guadalajara and Puerto Vallarta, participating hotels, airline partners, venues and their respective officers, employees, contractors and agents are not responsible for lost, late, incomplete, misdirected or technically corrupted entries; technical failures; or injury, loss or damage arising from participation in the Giveaway or acceptance, use, misuse, cancellation or inability to use a prize, except to the extent liability cannot legally be excluded.

13. RIGHT TO MODIFY, SUSPEND OR CANCEL

The Administrator reserves the right, subject to applicable law, to suspend, modify or cancel the Giveaway if fraud, technical failure, venue restrictions, force majeure, governmental action or another circumstance beyond reasonable control materially affects the integrity or operation of the Giveaway. If the Giveaway is modified or terminated, the Administrator may select winners from eligible entries received before the applicable change, where appropriate.

14. TAXES

Any federal, state, local or other taxes arising from the receipt or use of a prize are the sole responsibility of the winner unless otherwise required by law. Winners are responsible for obtaining their own tax advice regarding any prize received.

15. GOVERNING LAW

These Official Rules are governed by applicable United States federal law and, to the extent not preempted, the laws of the State of Illinois, without regard to conflict-of-law principles. Any provision that is unenforceable will be applied to the maximum extent permitted without invalidating the remaining provisions.

16. ADMINISTRATION AND CONTACT

The Giveaway is administered by Envoy Events in connection with its representation and activation services for the tourism promotion entities of Jalisco, Guadalajara and Puerto Vallarta.
